
About the International Humanitarian Studies Association

IHSA Conference on Humanitarian Studies

Our main activity in 2018 was the 5th edition of the IHSA Conference on Humanitarian Studies. This year the event took place in the city of The Hague, The Netherlands from 27-29 of August. The conference was hosted and co-organized by the International Institute of Social Sciences of Erasmus University Rotterdam. The title of the conference was: (Re-) shaping Boundaries in Crisis and Crisis Response.

The 4 themes in which the panels were divided:

- Changing Actors, Views and Challenges from Below
- Humanitarian Studies and the WHS Humanitarian Scholar Commitments
- The Changing Realities of Crisis and Responses to Crises, Including Humanitarianism
- The Impact of Technology and Innovation in Coping with, Responding to and Transforming Crisis

Security Guidelines - French Translation

In August 2018, a panel was held in honor of the publication of the French translation of the Security Guidelines - for field research in complex, remote and hazardous places (Dorothea Hilhorst, Lucy Hodgson, Bram Jansen, Rodrigo Mena). Newly appointed board member Virginie Troit and her team at Fondation Croix-Rouge worked on the French translation of the guidelines.

About the book: When conducting field-based research or field-work, researchers often operate within complex and dynamic social and political contexts, and derive their data from that environment. Both the quality of research and the security of the researcher are a function of how well-planned the research is, taking into account the local context and the risk environment.

This manual is designed to assist researchers in conducting their research in hazardous, remote or complex environments as safely and securely as possible, both for those working within their home country, or as foreigners. The focus of this manual is on the individual researcher, yet takes into account that the researchers' security planning is usually within the organisational procedures and processes of home or host organisations, designed to enhance the security of research staff and programmes.

Working Groups

New working groups were created in 2018:

Working Group on Ethics

The group has three main objectives: Firstly, it will interrogate and help advance ethical commitments in the field of humanitarian studies as formulated for example at the first World Humanitarian Summit in 2016. This objective includes more generally the study of the ethics of humanitarian actors and actions. Secondly, the group hopes to become a key point of reference for the ethical conduct of humanitarian research, in the Global North and the Global South. Thirdly, the group aims to advance the ethics of humanitarian studies with a special focus on fostering humanitarian studies in the Global South and encouraging responsible research uptake by its members but also across the humanitarian sector as a whole.

Working Group on Media

This group consist out of people who are interested in humanitarianism and the media. The objectives are to communicate the complexities of humanitarian crises to better educate and inform practitioners, academics, and ultimately the public at large. The group does this through IHSA's social media accounts, art, and the gathering of film and docs on humanitarian issues. Furthermore we aim to have an open and critical discussion with the other members about the role of media in the humanitarian field.

Committee on Diversity and Outreach

This new committee has three main objectives revolving around the themes of diversity and outreach. The first involves finding ways to diversify the composition of the IHSA board itself, to give voice to different perspectives in strategic planning for the association. The second is to support the diversification of the IHSA membership, in order to provide opportunities to a wide range of practitioners and academics engaged with humanitarian studies. And finally, the third objective is to develop innovative outreach activities to meet the first to objectives. As a general principle, diversity is not a goal in itself, but rather the creation of a vibrant and inclusive humanitarian studies community, one which is mutually supportive and sensitive to a wide range of voices.

Roundtable debate on the State of the Humanitarian System report

Every three years, after extensive research, ALNAP publishes the State of the Humanitarian System report. This December ALNAP will publish the 2018 edition, and KUNO, the Dutch Ministry of Foreign Affairs, the UN OCHA Centre for Humanitarian Data, the International Humanitarian Studies Association (IHSA) and the Dutch Coalition for Humanitarian Innovation (DCHI) organized its Dutch presentation to talk about its possibilities and pitfalls. This event took place at the Humanity Hub in the Hague on Dec 20.

Conference Publication

In April 2019, a collection of papers from the 2016 IHSA conference in Addis Ababa came out as a special issue of the journal Disasters.

Disasters is a major, peer-reviewed quarterly journal reporting on all aspects of disaster studies, policy and management. It provides a forum for academics, policy-makers and practitioners to publish high-quality research and practice concerning natural catastrophes, anthropogenic disasters, complex political emergencies and protracted crises around the world. The journal promotes the interchange of ideas and experience, maintaining a balance between field reports, case study articles of general interest and academic papers.

The Disasters journal is managed by the Humanitarian Policy Group (HPG) and published on behalf of Overseas Development Institute (ODI) by Wiley-Blackwell.

Abstract

This special issue of Disasters on humanitarian governance focuses on risk and order. Its contributions show the tensions between humanitarian normative ideals and practical consequences, as many of the ordering effects are associated with either intended or unintended consequences. This introduction offers a conceptual framing of humanitarian governance. Defining humanitarian governance as a subset of global governance, the paper shows how humanitarians have attempted to improve the consequences of their work by fighting instrumentalisation and instituting rationalisation processes. It adapts four questions, originally formulated by Michael Barnett (2013), to examine the ways in which humanitarian governance functions in more detail: what kind of world is being imagined and produced through the specific concern with order and risk? Who governs? How is this a form of humanitarian governance and how is it organised? And finally, what are the principal techniques of such governance? The conclusion summarises the main findings and sets an agenda for further research.




Financial Summary

In 2018, IHSA received the final part fo the grant money from the Municipality from the Hague. The majority of this money was used towards the organization of the 5ht IHSA conference on Humanitarian Studies.

In 2018, we also started with the sale of subscriptions. Since a subscription gives a discount on a conference ticket we noticed that almost every individual attending the conference would also buy a subscription. We generated 4525 euros in subscriptions this year.
